Short CV

Tore Haugen is professor in architectural management at NTNU – The Norwegian University of Science and Technology, Department of Architectural Design and Management. Haugen finished his doctor degree at NTNU in 1990, combined with studies at the University of California, Berkeley and at the Royal Institute of Technology, Stockholm. Haugen was full time employed dean of Faculty of Architecture and Fine Art during two periods from 2005 – 2013. Professor Haugen was the elected rector of the Nordic Academy of Architecture for the period 2013 - 2015.

Vision

The vision for CIB W70 is to strengthen the existing international research network for Facilities Management and Modernization, and to develop stronger connections with real estate research for the private and public sector.

Closer cooperation between research, education and practise networks will be part of the development of W70, and we will open up for more integrated and multidisciplinary research in cooperation with other CIB commissions and other networks.

The commission aims:

- to promote the strategic and operational value of facilities management and asset maintenance in meeting emerging business challenges
- to forge closer links and collaboration between the financial, technical, sociological and operational aspects of facilities management

- and asset maintenance through an integrated resource management approach
- to foster a deeper understanding of how our built environment influences human behaviour, health and organizational productivity
- to explore the role of facilities management in planning and delivering the transition of existing built assets to those that are fit for purpose in 20, 30 and 40 years' time ?
- to develop systems and business models for FM innovation based on use of new technology solutions for buildings and for future smart cities (service delivery, workplace models, Internet of Things, etc.)
- develop theories and models for service solutions and the performance of existing built assets under increasing pressure from climate change, societal demographics and new business models
- to explore how adaption and re-use of built assets based on new models for building conservation and renewal can support future urban living
- to disseminate the findings of research work on facilities management and asset management to a wider audience
- to provide a forum for the exchange of know-how and best practice in education, research and industry that addresses physical workplace and functional workspace demands
- to communicate the work of CIB W070 by publication of its symposium proceedings
- to arrange a biannual symposium / workshop (next in 2018), and to participate with a symposium or workshop in CIB World Congresses (next in Hong Kong June 2019)
